

Annex 4 - ALLERGENS

Pursuant to the Regulation on the Declaration, Labelling and Advertising Food, "Official Gazette of RS" no. 85/2013 and 101/2013, the following were defined:

Regulations of the Republic of Serbia	
Ingredients that may cause allergies and/or intolerances are:	
1.	Cereals containing gluten: wheat, rye, barley, oat, spelt, kamut and varieties obtained by their crossbreeding and their products, except: (1) wheat-based glucose syrup, including dextrose (and its products, in case the process to which they were submitted will not increase the allergy level estimated by EFSA for the relevant product from which they originate), (2) wheat-based maltodextrin (and its products, in case the process to which they were submitted will not increase the allergy level estimated by EFSA for the relevant product from which they originate), (3) barley-based glucose syrups, (4) grain distillates or ethyl alcohol of agricultural origin for the production of strong alcohol drinks obtained from grains;
2.	Shellfish (crustaceans) and shellfish products;
3.	Clams and other molluscs and their products;
4.	Eggs and egg products;
5.	Fishing products other than: (1) fish gelatine used as a carrier for vitamins and carotenoid preparations, (2) fish gelatine or swim bladder gelatine (Isinglass) for fining beer and wine;
6.	Peanut products made from peanuts;
7.	Soybeans and soybean products, except: (1) completely refined soybean oil and fat (6), (2) natural tocopherol mixtures (E 306), natural D-alpha tocopherol, D-alpha tocopherol acetate, D-alpha tocopherol succinate originating from soybeans, (3) separated phytosterol and phytosterol esters from soybean oil, (4) herbal stanol ester produced from soybean oil sterols.
8.	Lupine and lupine products;
9.	Milk and dairy products, including lactose, except: (1) whey used for production of distillates or ethyl alcohol of agricultural origin for strong alcohol drinks; (2) lactitol;

Nuts: almond (<i>Amygdalus communis</i> L.), hazelnut (<i>Corylus avellana</i>), walnut (<i>Juglans regia</i>), cashew (<i>Anacardium occidentale</i>), pecan (<i>Carya illinoensis</i>), Brazil nut (<i>Bertholettia excelsa</i>), pistachio (<i>Pistacia vera</i>), macadamia nut and Queensland nut (<i>Maccadamia ternifolia</i>) and their fruit, except: (1) nuts used for the production of distillates or ethyl alcohols of agricultural origin for strong alcohol and alcohol drinks;
11.	Celery and celery products;
12.	Mustard and mustard products;
13.	Sesame seed and sesame products;
14.	Sulphur dioxide and sulphites in concentrations larger than 10 mg/kg or 10 mg/l, expressed as SO ₂ , which is calculated for products that are ready for consumption or which were produced again in accordance with the manufacturer's instructions.
